**COUNCIL REPORT:**

Councilman Leonard reminded the committee that a Budget meeting with discussion regarding the Advisory Boards would be held Tuesday, May 3, 2022 at 4pm. The following week will be a budget workshop at 2:30pm and the regular work session of the Council on Thursday at 5pm.

A proposal was received by the Town for the Davis property to be rezoned to allow 300 houses to be built by the developer.

The Town will be re-establishing the 4<sup>th</sup> of July Parade and Picnic this year that had been cancelled due to COVID.

The Volunteer Picnic is being held Saturday, May 14, 2022 at 11 AM outside by the Municipal Bldg.

The Town has applied for a 5 million dollar grant to upgrade the Water/Sewer Plant but the estimated cost is around 9 million. Any new builds must be connected to town sewer and water.

There was a grant applied for to put in a road as a second ingress/egress but it was determined that anyone developing the Northwest Quadrant would be responsible to put another road in.

New Ordinances are in place. Discussion of moving the room and just meeting quarterly was discussed.

Old Business was called for. There was none

New Business:

Chairman reminded everyone of the volunteer picnic on the 14<sup>th</sup> of May and asked folks to put their name down if they were going.

Motion to suspend the meetings for July, August and September was made by Patty Leonard, seconded by Jon Hall. Motion passed unanimously.
